<p>For fiscal year 2019, 38 grant requests were received totaling approximately \$1,830,000. The revenue budgeted for fiscal year 2019 is anticipated to be approximately \$1,650,000. The Cheyenne Community Recreation District (CCRD) Board approved fiscal year 2018 grants in the amount of \$1,768,696. The approved projects have been addressed and the remaining work will be completed this summer. As of June 30, 2018, approximately \$675,000 has been spent on fiscal year 2018 projects. The operations budget of \$3,533,224 includes projects that will be approved for 2019 as well as carryover from projects approved in previous years. As those projects are completed the funds will be paid out.</p>		

S-B	<b>RESERVE DESCRIPTION</b>
<p>CCRD had one reserve for the replacement of synthetic turf fields around the District. On January 12, 2017 the CCRD Board voted to reallocate this money from the reserve to the synthetic turf at McCormick Junior High. As a result, the reserve was closed in 2017 and has no activity for fiscal years 2018 or 2019.</p>
